JIF Alternate Resolution

Resolution #17-02-01 (Attachment 3) designating Marisol Leguizamón the alternate Joint Insurance Fund (JIF) representative for ERHC was passed unanimously on a motion by J. Fonzino and a second by W. Wallace.

Resolution for Bank Access

Resolution #17-02-02 (Attachment 4) granting Marisol Leguizamón access to all bank accounts including cash management accounts was passed unanimously on a motion by K. Costello and a second by J. Fonzino.

Resolution for HERC services from HRHC

C. Nawrocki provided an update to the group on the search for a new Commission Epidemiologist.


NJACCHO and Essex County Health Officer's Association Update
